Items to be discussed include the following: We need to discuss the election ballot that is usually presented at the conference. Ballot does not have to be presented until the spring. Will post information on ListServe by late March, but will bring up need for VP Intern at the conference.

Refreshments for board meetings. The food for the Sept. 3 board meeting cost Janet and Ellen over \$100. Should we have CASL reimburse food costs at board meetings? Should we have more people provide refreshments each month? Should we have everyone bring \$5 each meeting to reimburse the cost of food? Other suggestions? Decision to keep it as it is. Report by Mary Shukie of Advocacy Committee, who attended one-day AASL Advocacy Workshop in New Hampshire. Is this something we want to bring to Connecticut as a one-day professional development program sometime in the near future? Mary Shukie said: the event has potential but the presenter was poorly prepared and handouts were out of order. I would not recommend it unless there was a different presenter. Also, the time allotted--8 hours--is too much for content to be covered. Quite honestly, the presenter did not have any new information. Would consider it for the future only if new information/topic would be presented.

Possibility of joint conference for 2009-10 school year with CLA or CECA. If were to have joint conference with CLA, would have to be in spring 2010, perhaps a one day special session devoted to schools (their conference is three days), with possibility of having a fall seminar/workshop to take place of fall conference. If went back to joint conference with CECA, question of what about CLA since they approached us first this year. David proposed having both. Joint conference with CECA in the fall, late October so as not to conflict with AASL and one in the spring with CLA. Moved by Irene, Second by Martha. Passed unanimously.

Nomination of Irene Kwidzinski as a lifetime honorary member. Moved by David, second by Shelly. Passed unanimously.
